LIVE AND LEARN PROVIDES CLIENTS WITH A STRUCTURED PATHWAY TO ECONOMIC INDEPENDENCE. WE DO THIS THROUGH PERSONALIZED CAREER PLANNING, EDUCATION, TRAINING, MENTORING, AND FINANCIAL ASSISTANCE. PROGRAM STAFF PROVIDE HIGHLY INDIVIDUALIZED SUPPORT TO EACH LIVE AND LEARN PARTICIPANT OVER A TWO-YEAR PERIOD. FUNDING CAN COVER EACH WOMAN'S DIRECT AND INDIRECT BASIC SKILL BUILDING AND TRAINING/EDUCATION COSTS (WHOLLY OR IN-PART), CERTIFICATION/LICENSURE ACQUISITION, AS WELL AS FINANCIAL ASSISTANCE ON AN AS-NEEDED BASIS FOR ESSENTIAL LIVING EXPENSES, AND/OR UNFORESEEN EMERGENCY EXPENSES, THAT COULD OTHERWISE DERAILED OR SERIOUSLY DELAY COMPLETION OF THE PROGRAM. 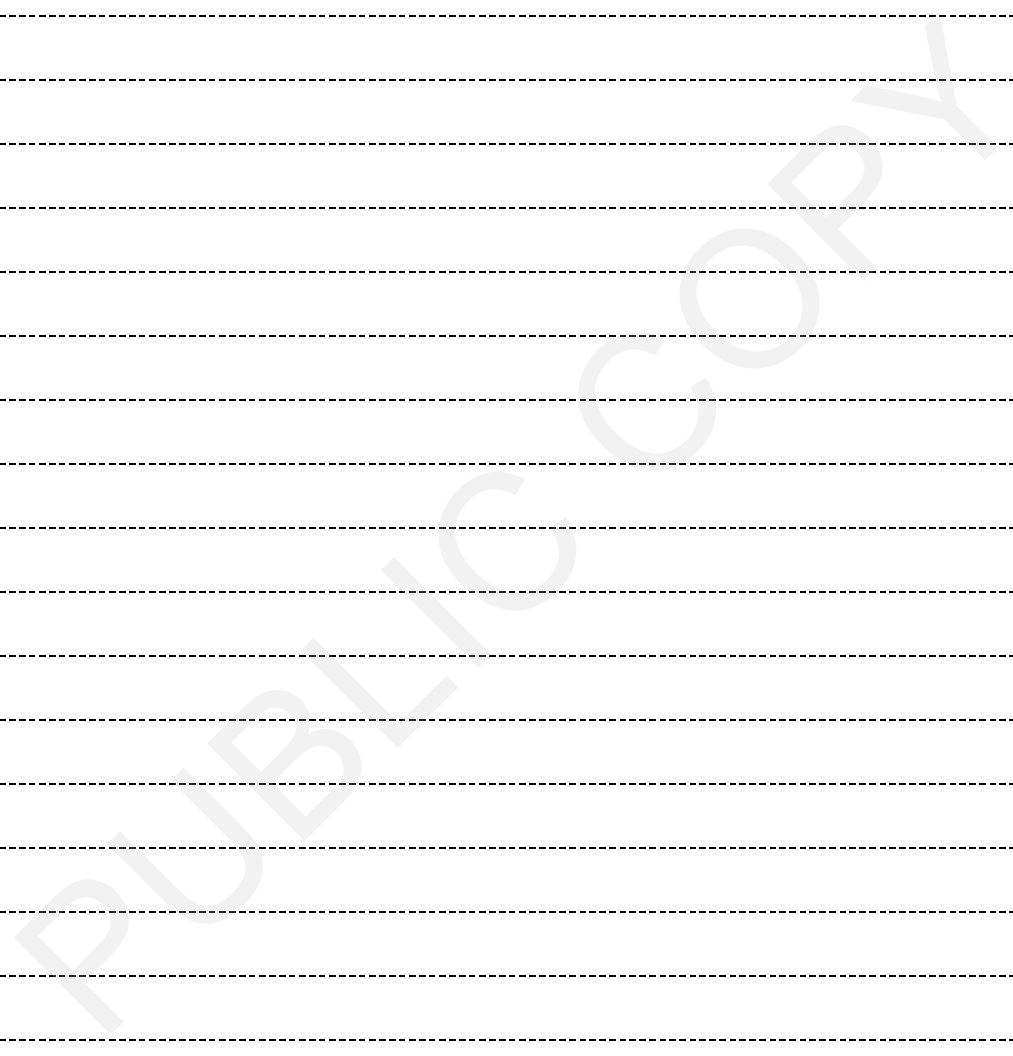
