OUR SUPPORT ALLOWED 164 WOMEN TO ENROLL IN CERTIFICATION AND DEGREE PROGRAMS; 56% WERE THE FIRST IN THEIR FAMILY TO PURSUE POSTSECONDARY EDUCATION. OVER 12 MONTHS, 102 WOMEN RECEIVED ONGOING, 1:1 COACHING TO DEVELOP JOB READINESS SKILLS, APPLY FOR JOBS, INTERVIEW, AND SECURE AND RETAIN FULL-TIME EMPLOYMENT. WE HOSTED 26 FINANCIAL LITERACY WORKSHOPS TAILORED TO THE NEEDS OF WOMEN IN POVERTY.
