WE PROVIDE CONCRETE PATHWAYS TO EMPLOYMENT AND ECONOMIC EMPOWERMENT THROUGH EDUCATION AND CAREER TRAINING, AND PROVIDE WRAP-AROUND SERVICES AND SUPPLEMENTAL SUPPORT INCLUDING MENTORING AND BASIC SKILL-BUILDING TO MAXIMIZE OUR CLIENTS' SUCCESS RATE. OUR CLIENTS ARE THE FIRST IN THEIR FAMILY TO COMPLETE HIGH SCHOOL, THE FIRST TO ATTAIN POST-SECONDARY EDUCATION, AND THE FIRST TO PURSUE A PROFESSIONAL CAREER. OUR PROGRAM'S GOAL IS FOR CLIENTS TO SECURE LIVABLE WAGE EMPLOYMENT, ALLOWING THEM TO LIFT THEMSELVES AND THEIR CHILDREN OUT OF POVERTY. IN 2017 LIVE AND LEARN ASSISTED OVER 150 WOMEN TO REACH ECONOMIC SELF SUFFICIENCY.
