IN 2024, LIVE AND LEARN SERVED 175 WOMEN IN MARICOPA COUNTY, MOST OF WHOM FACED SIGNIFICANT BARRIERS SUCH AS MOTHERHOOD (56%), DOMESTIC VIOLENCE (34%), RELIANCE ON GOVERNMENT ASSISTANCE (35%), HOMELESSNESS (35%), AND SUBSTANCE USE DISORDER (11%). DESPITE THESE CHALLENGES, 11 WOMEN EARNED A DEGREE OR CERTIFICATION, AND 70 WERE THE FIRST IN THEIR FAMILIES TO PURSUE HIGHER EDUCATION. LIVE AND LEARN PROVIDED 698 HOURS OF ONE-ON-ONE SUPPORT AND HOSTED 65 WORKSHOPS WITH 83% PARTICIPATION COVERING TOPICS SUCH AS MENTAL HEALTH, DIGITAL LITERACY, FINANCIAL COACHING, JOB READINESS, AND CAREER COUNSELING. ADDITIONALLY, WE FACILITATED 144 HEALTHCARE CONNECTIONS AND 38 COMMUNITY PARTNER REFERRALS, HELPING WOMEN BUILD STABILITY, PURSUE EDUCATION, AND MOVE TOWARD LONG-TERM INDEPENDENCE.
